Executive Summary

"Promotion of responsible pet ownership through education, encouragement and enforcement"

Recent amendments to the *Domestic (Feral and Nuisance) Animals Act 1994* has legislated all Victorian Councils develop and prepare a Domestic Animal Management Plan.

During the development of this plan, Frankston City Council embraced the opportunity to engage with stakeholder groups, the broader community, and Council's Animal Management Team. Feedback and suggestions obtained have been integrated into the Plan's strategic directions.

Strategies developed have been thoughtfully considered to ensure:

- They are realistic and achievable
- A balance is achieved between needs of pet owners and the needs of the community in general
- Council's overarching plan and vision is taken into consideration and incorporated where appropriate
- Legislative requirements of the Act are met



1.0 Introduction and Context

1.1 PURPOSE

The Domestic Animal Management Plan sets the strategic direction in terms of animal management within Frankston City for the next three years, allowing for review on an annual basis. It will reflect what Council does in relation to animal management and will develop ways to improve current practices and set future directions and action plans.

The Domestic Animal Management Plan is a State Government requirement under the *Domestic (Feral and Nuisance) Animals Act 1994*. The development of the Domestic Animal Management Plan was guided by the Department of Primary Industries – Bureau of Animal Welfare, across all Victorian municipalities. The Plan aims to increase the relative profile and importance of the domestic animal management function in the local government sector.

1.2 PROCESS APPLIED IN DEVELOPING THIS PLAN

Frankston City Council's Domestic Animal Management Plan has been developed in consultation with:

- Frankston City Council's Animal Management Team
- A stakeholder reference group - (including *Lost Dogs Home and Cat Shelters, Dogs Victoria, Cat Protection Society, local veterinarians, local pet shop owners*)
- Broad community consultation with both pet and non-pet owners

Existing domestic animal management services were reviewed against both community needs and the requirements of the *Domestic (Feral and Nuisance) Animals Act 1994*.

1.3 FRANKSTON CITY COUNCIL – DEMOGRAPHIC PROFILE

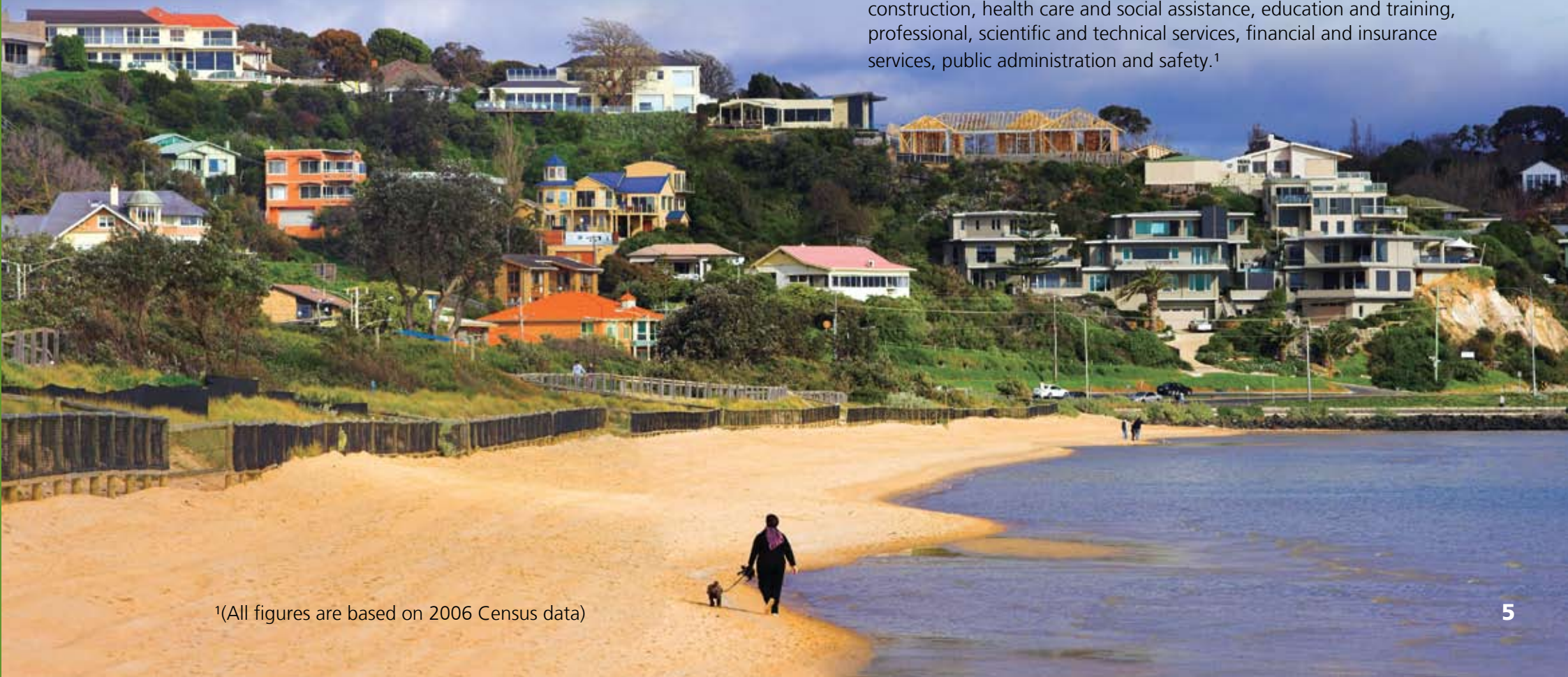
Frankston City is a regional capital located approximately an hour's drive from Melbourne on Port Phillip Bay. Frankston City is bordered by the Cities of Kingston and Greater Dandenong in the north, the City of Casey in the east, Mornington Peninsula Shire in the south and Port Phillip Bay in the west.

Frankston City is a predominantly residential area, with some industrial, commercial and rural areas. The City encompasses a total land area of 129.6 square kilometres. Central Frankston functions as the major regional retail and commercial centre, servicing outer southern Melbourne and the Mornington Peninsula.

Frankston City has a largely suburban population comprising approximately 121,587 residents and approximately 48,948 dwellings with the average household size being 2.51 persons.

The community comprises largely Australian born (83,608) or Australian citizens (98,805), with the majority of the population being in the 18-64 year age bracket (72,413).

Frankston City has a strong employment base with an estimated labour force of 56,989, of which 18,066 were employed part-time (31.7%) and 33,966 were full time workers (59.6%). The most frequented industries in which residents work are: wholesale and retail trade, manufacturing, construction, health care and social assistance, education and training, professional, scientific and technical services, financial and insurance services, public administration and safety.¹

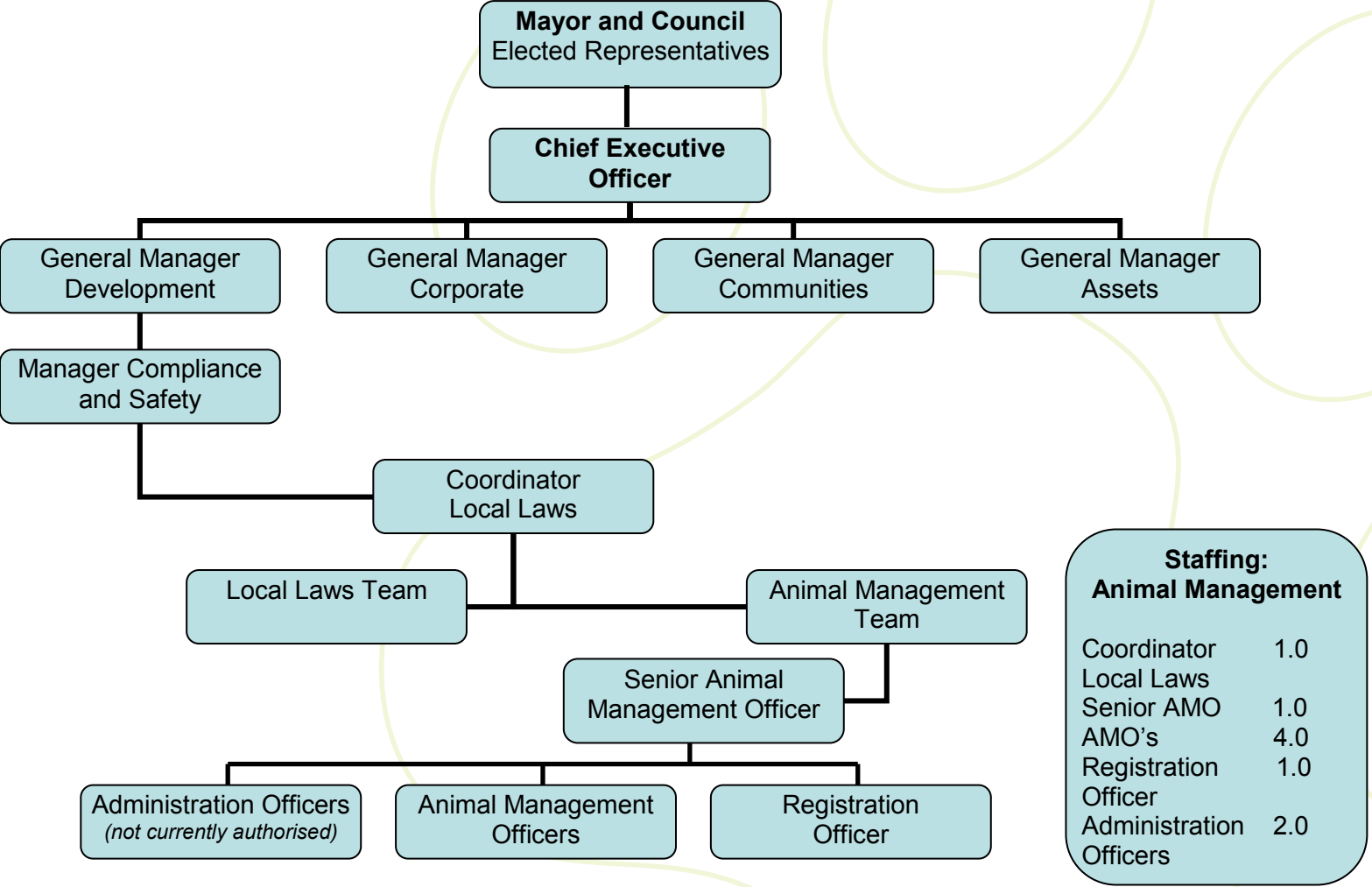

1.7 IDENTIFICATION OF KEY ISSUES FOR FRANKSTON CITY - COMMUNITY AND STAKEHOLDER CONSULTATION

A widely inclusive consultation process was undertaken to obtain feedback and suggestions in regard to responsible animal management across the municipality. Feedback and suggestions obtained have been integrated into the Plan's strategic directions.

Community Survey – Responsible Pet Ownership

Council consulted the community about issues regarding responsible pet ownership – and how these issues affect individuals and neighbourhoods. Council also asked residents to provide suggestions for measures which may be implemented to address any issues.

Council's Domestic Animal Management Reference Group developed a questionnaire, which was distributed to the community. 3352 written questionnaires were mailed out to a random selection of dog owners, cat owners and non-pet owners from Council's databases. Additionally, a further 330 questionnaires were e-mailed to members of Council's community consultation database in an online format.

The survey was also available to the community on Council's Web site, in libraries, customer service centres and local veterinary clinics.

1156 responses were received and processed, which is a very good response rate and is indicative of the high level of community interest in this issue.

The survey identified the following issues as the key matters of concern to the community:

- Roaming dogs and cats
- Dogs barking
- Dog droppings
- Dogs walked off lead

Other issues more specific to cat owners were:

- > Cats not allowed off properties at night – and the perceived difficulty in confining cats
- > The possibility of a 24 hour cat curfew
- > Other cats roaming

Other issues more specific to dog owners were:

- > Perceived lack of free roam / free leash areas
- > Dog on dog attacks



Community Workshop Evening – 15 July 2008

The purpose of this discussion was to workshop ideas and strategies which may assist in addressing the key issues identified as part of the responsible pet ownership community survey.

A common theme arose from this discussion for each of the issues discussed:

- Improved community education
- Improved communication across the spectrum of responsible pet ownership issues

Animal Management Officer Workshop – 17 July 2008

Frankston City Council's Animal Management Team also workshopped ideas and strategies, based on the feedback received from the responsible pet ownership community survey.

The Animal Management Team was specific with their feedback, and able to offer detailed suggestions based on their industry experience:

- Improved level of community education and communication, for example:
 - > New pet owners checklist (DL brochure) – to be distributed via pet shops, breeders and veterinarians
 - > Introduce an eight-week subsidised basic dog training course via Dogs Victoria
 - > Continue to promote responsible pet ownership to children and continue support of Department of Primary Industries (DPI) schools program
 - > Education regarding securing dogs – show what happens when dogs attack
 - > Education regarding cats – breeding patterns, trapping programs, containment requirements and methods, fines
 - > Introduce a dog / cat hotline for residents
 - > Information stalls – shops and hotspots
 - > Information stalls at Council events (eg. Waterfront Festival, Seniors' Fair)
 - > Talking to groups
 - > Introduce a community education officer
- Further encourage registration, microchipping and desexing of dogs and cats, for example:
 - > Promote merits of microchipping and desexing of dogs and cats (e.g. keeping pets safe, 99% of pets are returned if they are microchipped)
 - > Utilise media better including Council's Web site and Pet Talk pages in local newspapers
 - > Better promote Council's subsidised desexing program for concession card holders
 - > Door knocks
 - > Monthly prize draw of new registrations

- Review free roam areas in Frankston City, for example:
 - > Review possibility of additional free roam areas in the municipality
- Dog waste, for example:
 - > Educate the community further regarding fines and enforcement
 - > Continue with A-frame signage and patrols

Domestic Animal Management Plan Reference Group

This group was created to enable Council to consult specifically with a spectrum of industry stakeholders, and included members from the Lost Dogs Home, Cat Shelters, Dogs Victoria, Cat Protection Society, local veterinarians and local pet shop owners.

The group initially worked together to formulate the responsible pet ownership community survey, and then again to workshop key issues identified as part of the survey.

Suggestion themes from this discussion:

- Community education
 - > Implementation of an education officer
 - > Take education programs to the community/neighbourhood areas (e.g. community houses)
 - > Breed suitability for lifestyle education
 - > Education for children
 - > Cat containment education – reasons for keeping cats safe, and cost effective confinement methods
- Communication
 - > Improve communication with industry stakeholders – working together
 - > Improve awareness of services and programs available (e.g. desexing program)
 - > Improve signage (e.g. maps in parks indicating locations of dog waste bins)
 - > Implementation of a new dog and cat hotline for residents
- Need to understand and address, the underlying cultural issues affecting the community's attitude and response towards responsible pet ownership in the municipality in the long term.

COUNCIL'S ANIMAL MANAGEMENT TEAM

Frankston City Council's Animal Management Team is situated within the Compliance and Safety Department. The purpose of this department is to contribute to the Council Plan Strategic Objectives by:

Protecting and promoting:

- *The safety, health and well being of residents*
- *The amenity and environment of Frankston*

Through the provision of a range of innovative customer focussed services and programs in a cost effective manner.

The main focus of the Domestic Animal Management Plan is to achieve a balance in meeting the needs of the community – including both pet owners and non pet owners.

3.0 Strategic Directions for Domestic Animal Management

3.1 AMO TRAINING AND DEVELOPMENT

Objective:

To ensure all staff involved in animal management have the knowledge and skills necessary to carry out their work

Current/Ongoing Activities:

- All staff are required to undertake a minimum of 24 hours learning and development, per officer, annually – as part of individual personal development programs
- On the job training, plus ongoing coaching
- It is desirable, but not essential, for new staff to hold minimum Certificate IV in Animal Control and Regulation – or have appropriate industry experience/other relevant qualifications
- Staff representative on relevant industry bodies and committees

Planned Initiatives:

- Conduct Animal Management Officer skills audit to determine training gaps
- Apply for DPI scholarships for Animal Management Officers (Certificate IV in Animal Control and Regulation)

3.2 ENCOURAGING RESPONSIBLE PET OWNERSHIP – COMMUNITY EDUCATION

Objective:

To encourage people to manage pets in a way which protects the health and welfare of the animal; maximises the companion benefits of their pet; and minimises potential for nuisance or harm to others.

Current/Ongoing Activities:

- Conduct annual Pets Day Out event
- Actively promote DPI's Responsible Pet Ownership Program to local schools
- Provide a range of educational materials for the community
- Regular media releases/articles in local newspapers/articles in Council's community newsletter, Frankston City News regarding responsible pet ownership issues
- Use of Council Web site as promotional tool, including links to other relevant industry Web sites
- Utilisation of Council's on-hold message facility as a promotional tool
- Participation with pet group activities (e.g. Dogs Victoria)

Planned Activities:

- Consider engagement of an Education Officer to:
 - > Promote the benefits of responsible pet ownership
 - > Promote the benefits of suitable breeds chosen for lifestyle
 - > Promote resident reporting of incidents, by utilising proposed 'dog and cat hotline'
 - > Improve awareness of current night time cat curfew requirements, and containment methods available for the community
 - > Manage effective media campaigns in the future to improve community awareness of services, programs and regulations in relation to all aspects of responsible pet ownership
 - > Actively participate in the Victorian State Government's 'Who's for Cats' program, which seeks to address issues around semi-owned cats
 - > Develop education programs which can easily be 'taken to the community'
 - > Conduct information programs, including stalls at shops, hotspots, and Council events (e.g. Waterfront Festival, Seniors' Fair)
 - > Build on relationships with industry stakeholders
- Creation of a New Pet Owner Checklist – DL sized brochure – outlining requirements when new pets are obtained – to be distributed via Council, pet shops, breeders and veterinarians
- Introduce an eight-week subsidised basic dog training course through Dogs Victoria and/or Frankston Dog Obedience Club
- Review signage in reserves regarding the location of dog waste bins and bags

3.3 IDENTIFICATION AND REGISTRATION

Objective:

To maximise the number of registered and identifiable domestic animals, in order to aid compliance activities and to help reunite lost pets with their owners.



Current/Ongoing Activities:

- Doorknock campaigns
- Use of local media and Web site to promote registration requirements
- Desexing voucher program for concession card holders
- Discounted microchipping at annual Pets Day Out event

Planned Activities:

- Reward responsible pet owners by conducting monthly prize draws for new dog and cat registrations
- As it is compulsory to desex and microchip all newly registered dogs and cats in Frankston City, (some exceptions are allowed under the Domestic (Federal Nuisance) Animals Act 1994), undertake further promotion of the regulations, but also ways in which Council may provide assistance with:
 - > Desexing voucher program
 - > Discounted microchipping at annual Pets Day Out event
- Consider conducting discounted microchipping at targeted local neighbourhood areas
- Introduce mobile computing facilities in Animal Management vehicles to enhance access to information such as the pet registration database

3.4 COMPLIANCE AND ENFORCEMENT – LOCAL LAWS AND ORDERS

Objective:

To maximise compliance with domestic animal laws, orders and regulations (State and Local).

Current/Ongoing Activities:

- Issue cautions and infringement notices
- Investigate complaints
- Routine patrols conducted regularly
- Cat cage system

Orders currently in place:

- Designated dog off leash areas
- Designated 'No dogs and cats allowed' areas
- Dog must be under effective control in a public place
- Pet owners to remove faeces from public places and carry a means to collect faeces
- No more than two dogs or cats to be kept on a residential property without a permit
- Night time (dusk until dawn) cat curfew
- Mandatory registration of dogs and cats at age of three months
- Mandatory microchipping of all newly registered dogs and cats
- Mandatory desexing of all newly registered dogs and cats, excluding animals exempted under the Domestic (Feral and Nuisance) Animals Act 1994.

Planned activities:

- Investigate the option of establishing a 24 hour cat containment program in the Frankston City municipality
- Investigate the possible establishment of additional free roam areas in the municipality, including the foreshore area

- Explore the possibility of introducing a dog and cat 'hotline' for residents
- Conduct patrols of hotspots identified through the dog and cat 'hotline'
- Review local laws and orders to ensure Domestic Animal Management Plan objectives are met
- Review number and distribution of dog waste bins / dog waste bags and amend or increase as required (currently 54)

3.5 DOMESTIC ANIMAL BUSINESSES

Objective:

To work in partnership with Domestic Animal Businesses to achieve Council's domestic animal management goals.

Current / Ongoing Activities:

- Domestic Animal Businesses actively monitored for compliance periodically as required
- Investigation of complaints/enforcement action for non-compliance
- Supply and distribution of information regarding Domestic Animal Management Businesses and relevant codes of practice

Planned Activities:

- Implement agreements with Domestic Animal Businesses regarding providing the proposed New Pet Owner Checklist to people who purchase pets
- Provide annual Council/Domestic Animal Business Workshops for sharing information

3.6 DECLARED DOGS

Objective:

To minimise the risks of dog attack to the community from aggressive dogs.

Current/Ongoing Activities:

- Annual inspections of dangerous/restricted dogs for compliance
- Prosecute non-compliant owners
- Investigation of complaints
- Ensure all dogs declared by Council are recorded on the Victorian Declared Dog Registry
- Supply and distribution of literature and pamphlets regarding the regulations for keeping dangerous dogs

Planned Activities:

- Actively patrol commercial and industrial areas to identify dogs on premises



4.0 Performance Monitoring and Evaluation

Frankston City Council will monitor performance of the animal management services detailed in this Plan by reporting annually through Council's established reporting systems.

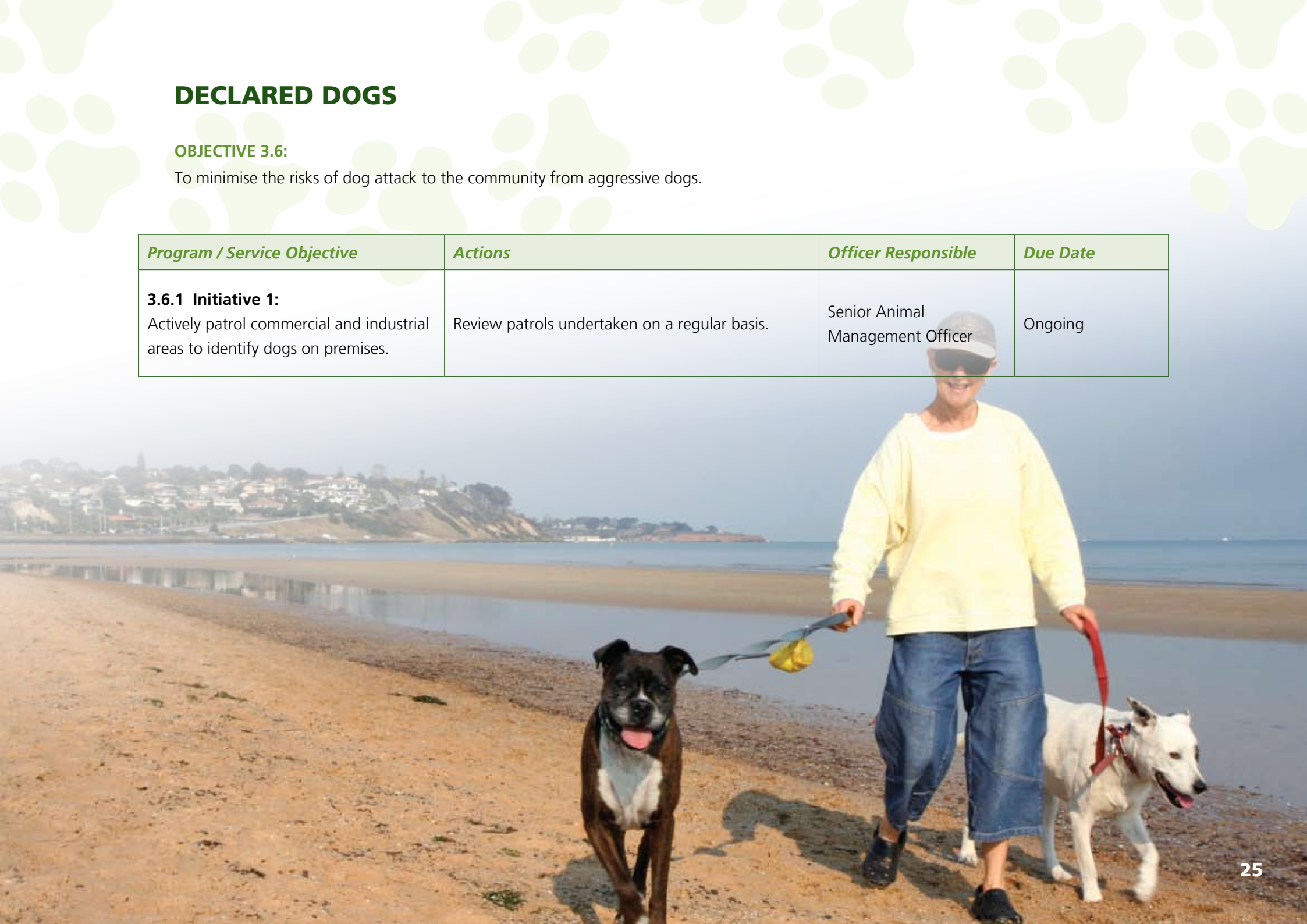
